This forecast of prime and subcontracting opportunities with the U.S. Department of Energy and its major prime contractors, is the Department's best estimate of new procurement opportunities potentially to be set-aside for small, small disadvantaged and woman-owned small businesses in fiscal year 2000. The information contained in the forecast is published in compliance with Public Law 100-656, "Business Opportunity Development Reform Act of 1988." It is not an Invitation for Bid, a Request for Proposal, or a commitment by this Department to purchase products or services. Each procurement opportunity is based on the best information available at the time of publication and may be revised or canceled.

### **FORWARD**

Welcome to the United States Department of Energy's (DOE) procurement and assistance opportunities which are set-aside for small, small disadvantaged, 8(a) certified, woman-owned and HUBZone certified small business concerns. We appreciate your interest in becoming a contractor with DOE or its prime contractors. The Department's mission would be difficult to accomplish without your support. Accordingly, we hope that this forecast, designed to help small firms identify procurement opportunities early in the acquisition process, will assist you in doing business with the Department.

The Department of Energy and its major prime contractors purchase a wide variety of goods and services ranging from small commercial supplies to complex research and development expertise. This forecast includes only anticipated contract actions of \$100,000 and above, which are expected to be set-aside for small business concerns. However, small business contractors are reminded that numerous procurement opportunities under \$100,000 also exist for small business participation, as does opportunities through the unrestricted procurement method.

To inform you of additional opportunities to do business with DOE, we included a listing of contracts performed by 8(a) certified firms that will expire in fiscal year 2000, as well as information on grant opportunities with the Small Business Innovation Research Program, the Small Business Technology Transfer Program, and the Inventions and Innovation Program, each specifically directed to small business concerns.

### MISSION

The United States Department of Energy (DOE) has a mission to foster a secure and reliable energy system that is environmentally and economically sustainable, to be a responsible steward of the Nation's nuclear weapons, to clean up our own facilities, and to support continued United States leadership in science and technology. Four business lines effectively utilize and integrate our unique scientific and technological assets, engineering expertise, and facilities to achieve our mission and to benefit the Nation. These business lines which directly affect the security and the quality of life of every American citizen, are:

- **#** Energy Resources--How we will assure adequate supplies of clean energy, reduce U.S. vulnerability to supply disruptions, encourage efficiency and advance alternative and renewable energy technologies, and increase choices for all consumers.
- **National Security**--How we will effectively support and maintain a safe, secure, and nuclear weapons, provide technical leadership for national global nonproliferation and nuclear safety activities, and develop and support nuclear reactor plants for naval propulsion.
- **Environmental Quality**--How we will reduce the environmental, safety, and health risks and threats from DOE facilities and materials, safely and permanently dispose of civilian spent nuclear fuel and defense related radioactive waste, and develop the technologies and institutions required for solving domestic and international environmental problems.
- **Science and Technology**--How we will use the unique resources of the Department's laboratories and the country's universities to maintain leadership in basic research and to advance scientific knowledge, focus applied research and technology development in support of the Department's other business lines, contribute to the Nation's science and mathematics education, and deliver relevant scientific and technical information.

### **DOING BUSINESS WITH DOE**

If you have a product or service to sell, it's probably something that DOE and its major prime contractors buy. Each fiscal year, DOE's procurement budget of \$15+ billion is contracted and subcontracted to purchase a variety of products and services from large and small contractors. Most of DOE's procurement dollars are subcontracted by its major prime contracts which offer the greater opportunity for doing business with DOE.

### Where to Start

This forecast offers a good starting point for marketing to DOE, as the opportunities contained herein, have been identified potentially for small business participation. It contains only opportunities of \$100,000 and above. You can begin by either finding your SIC code(s) in the SIC Code Reference Directory found on page 7 in this publication. Then identify the page(s) on which opportunities for your SIC code(s) are found. Each opportunity offers a point of contact and phone number. After reviewing all possible opportunities for which your firm might qualify, consult the point of contact for additional information on the procurement opportunity. Another way of identifying requirements is simply by perusing the section entitled, "Contracting and Subcontracting Opportunities."

If you require additional assistance in locating procurement opportunities, contact the Small Business Program Manager at the DOE location in the geographical area in which you have an interest in doing business. In future years, the forecast will list the North American Industry Classification System (NAICS) which replaces the Standard Industrial Classification system. The NAICS provides common industry definitions for Canada, Mexico, and the United States. It replaces the countries' separate classification systems with a uniform system for classifying industries. ### What DOE Buys

DOE buys a variety of products services, including commercial products, computers and peripherals, information technology, A&E and construction services, security and janitorial maintenance services, fiber optics, equipment, training, industrial materials, chemical and laboratory supplies and services, office supplies, environmental assessments, and basic and applied research.

### Where DOE Buys

DOE has a national network of Government-owned, contractor-operated facilities, including research laboratories and production sites, managed by major prime contractors and universities located

throughout the United States. A map of DOE's facilities can be found on page 1a of this publication. ### **How DOE Buys**

DOE buys products and services through a variety of procurement programs authorized by Federal and DOE acquisition regulations. It procures its requirements through methods familiar Federal and DOE acquisition regulations. It procures its requirements through methods familiar to most contractors, i.e., unrestricted competition, sole source awards, small business, 8(a), and HUBZone set-asides. Other methods are generally used for procurements of \$100,000 or less.

The Federal Acquisition Streamlining Act of 1994 (FASA) and the Federal Acquisition Reform Act of 1995 changed significantly the way the Federal government procures products and services. FASA requires Federal agencies to adopt electronic procurement and payment procedures through a Federal Acquisition Computer Network (FACNET). *FACNET* will allow suppliers to obtain information on proposed procurements, submit responses to solicitations, query special databases, and receive awards on a governmentwide basis.

The term "simplified acquisitions" has replaced the term "small purchases." *Simplified acquisitions*, which have a \$100,000 threshold, usually are reserved for small businesses. In 1989, the federal Government introduced the Governmentwide Purchase Card to simplify purchases of routine products and services. Since its inception, use of the purchase card has grown rapidly throughout the federal sector.

### Governmentwide Purchase Card

DOE and its major prime contractors hold approximately 5000 purchase cards. The purchase card is used almost exclusively for micro purchases up to \$2,500. It is frequently used for small purchases up to \$25,000, and is less frequently used for purchases up to \$100,000. ### ABOUT THE FORECAST

This forecast represents DOE's foreseeable procurement opportunities which it anticipates offering small business concerns during fiscal year 2000. The following key procurement methods and terms are contained herein:

### **Key Procurement Methods**

Primary procurement methods contained in the forecast are:

- < section 8(a) set-asides
- < small business set-asides
- < HUBZone set-asides
- < 8(a) Pilot Program set-asides

Section 8(a) set-asides are available to firms certified by the U.S. Small Business Administration. These firms include small disadvantaged businesses (SDB) and other firms deemed to be socially and economically disadvantaged. Small business set-aside opportunities are available to all small businesses (SB), including small disadvantaged and woman-owned business (WOB) concerns.

*Small business set-asides* are acquisitions of \$100,000 or above which are reserved exclusively for small business participation when there is a reasonable expectation that 1) offers will be obtained from at least two responsible small business concerns and 2) award will be made at fair market prices.

#### HUBZone set-asides

The HUBZONE program seeks to encourage economic development in historically underutilized business zones—HUBZones through establishment of preferences for ward of Federal contracts to small businesses located in such areas. A "HUBZONE is an area that is located in one or more of: a qualified census tract, a qualified non-metropolitan county, or lands within the external boundaries of an Indian reservation. A business concern may be determined to be a "qualified HUBZONE small business concern" if: 1) it is located in a "historically underutilized business zone," it is owned and controlled by one or more U.S. citizens, and at least 35% of its employees reside in a HUBZONE. The Department of Energy is one of the agencies participating in the HUBZONE program with a goal of 1.5% for fiscal year 2000.

The *8(a) Pilot Program* mimics the Small Business Administration's section 8(a) program, except that it is conducted by DOE's major prime contractors and the contractual arrangement results in a bipartisan agreement between the prime contractor and the 8(a) firm. Awards up to \$3 million made be made non-competitively to an section 8(a)-certified business concern and awards above \$3 million (\$5 million for manufacturing) are competed among section 8(a)-certified business concerns.

Some procurement opportunities contain the statement, "*Procurement Method Undetermined*." At the time this forecast was compiled, the procurement methods for these opportunities were unknown. However, it is anticipated that each opportunity has strong potential for a small business, section 8(a), HUBZONE or 8(a) Pilot set-aside.

### **Key Terms Used in the Forecast**

Each listed opportunity contains the following information which you have indicated to be helpful to you in marketing to DOE:

- SIC Code: The numerical industrial designation contained in the Standard Industrial Classification Manual. Inclusion of SIC codes in this publication is intended to be helpful to small business concerns. However, small businesses are advised that the SIC codes contained in the forecast are proposed and may not represent the final SIC determination. Final SIC determinations are made by the contracting officer, and in the case of a section 8(a) procurement, by the contracting officer and the U.S. Small Business Administration.
- **Description of Procurement Opportunity:** A brief description of the procut or service being procured.
- **Estimated Dollar Value:** An estimate of the dollar value of the product or service being procured, including option years, multiple contract opportunities and task orders.
- **Expected Solicitation Release:** Anticipated solicitation release dates are one of the four federal government quarters—

**Procurement Method:** Section 8(a), small business, HUBZONE, or 8(a) Pilot Program set-aside. **Point of Contact:** Each procurement opportunity lists the name of a point of contact who is familiar with the opportunity. The contact may be the Small Business Program Manager, contract specialist or technical representative.

**Phone Number:** Each procurement opportunity contains the phone number for the point of contact.

#### OTHER OPPORTUNITIES TO DO BUSINESS WITH DOE

#### **Grant Opportunities**

Grant awards and other financial assistance instruments offer another way to do business with the Department of Energy. Several departmental programs aimed at expanding opportunities to small business concerns award grants to firms meeting the selection and program criteria. These programs include:

- Small Business Innovation Research Program (SBIR) has an objective to stimulate technological innovation; use small business to meet Federal research and development needs; increase private sector commercialization innovations derived from Federal research and development; and to foster and encourage participation by minority and disadvantaged persons in technological innovation. The DOE SBIR Program is administered by the Office of Science (SC) which issues an annual solicitation for Phase I grant applications in the technical areas of basic energy sciences, biological and environmental research, high energy and nuclear physics, fusion energy, energy efficiency and renewable energy, nuclear energy, environmental management, nonproliferation and national security, advanced scientific computing, and fossil energy. The award amount for Phase I is \$100,000 for six months Approximately 200 awards are planned for Phase I on numerous topics. The SBIR solicitation opens November 29, 1999 and closes February 29, 2000. - Small Business Technology Transfer Program (STTR) reserves 0.15 percent of an agency's extramural research or research and development budget for awards to small businesses for cooperative research and development to be conducted jointly with a non-profit research institution. As in the SBIR Program, described above, a solicitation for grant applications is issued at least once a year by the Office Science (SC). Phase I is to determine feasibility, Phase II is to conduct the bulk of the research and development, and Phase III is to pursue commercialization. The award amount for Phase I is \$100,000 for nine months. Approximately 15-20 awards will be made for Phase I. The STTR solicitation opens November 29, 1999 and closes February 29, 2000. - Inventions and Innovation Program. The Office of Industrial Technologies' (EE) Inventions and Innovation Program provides up to \$200,000 in financial assistance for conducting early development and establishing technical performance of innovative, energy-saving ideas and inventions. Projects must fall within the areas of industry, buildings, transportation, or power, and those relating to the most energy-intensive industries—agriculture, aluminum, chemicals, forest products, glass, metalcasting, mining, petroleum, and steel—will receive special consideration. The program is limited to small businesses and individual inventors are especially encouraged to participate. The program is now accepting preliminary applications for year 2000 funds, and the formal solicitation will tentatively open in early May 2000.
